The income type codes WA, OA, and OF are used to budget income. The income type code WA counts income for both CA and NA. The OA income type code counts income just for CA, and the OF income type code counts income just for NA.

General Information: EBT Online Purchases

ALDI grocery stores now accept EBT benefits for purchases online. ALDI online purchases can be

made at www.instacart/aldi.

Local grocery store customers may have the following options:

- Pick up the items ordered at the store.
- Have the items delivered to a specific address provided by the participant.

Not all grocery stores offer the delivery option, or they may not be able to deliver to a specific address. Participants should contact the store for the options available, including delivery cost options.

NA benefits cannot be used to pay for delivery fees. CA participants can use their CA EBT Account to pay for fees. For more information, see [FAA Pilot Programs](#) in the CNAP Manual.
