### Reformat Update

The CNAP and CNAP+ Manuals are going through a reformatting project to change the look and feel, move the Table of Contents out of an AZTECS roadmap flow, and reduce the number of references to make it easier to find what is needed.

Recently a survey was sent asking for feedback about the format changes that were made. A big 'thank you' goes to everyone that responded. The survey results have been reviewed and are as follows:

- Over 60% like or love the completed reformatting changes
- Over 96% like it, love it, or are OK with it.

Since most of the comments were positive, the FAA Policy Support Team (PST) will continue in this direction to reformat the rest of the CNAP and CNAP+ Manual references.

The reformat group, which contains members representing many sections of FAA, continues to review the great survey suggestions provided to incorporate as many as possible. The PST completed following changes based on the survey comments:

- A comment identified that it was not intuitive that the gray box at the top of the page contained mini menu navigation links. Therefore, the gray box links were changed to blue and underlined so everyone knows these are links to different sections of the volume, chapter, or page.
- To help those with visual impairment, we have changed the apple and dollar sign images for NA and CA at the top of the reformatted page to images with crisper edges.
