Change: Transferring Applications to the FAA Refugee Offices

EFFECTIVE DATE: For applications received on or after 02/06/2023

The procedures for transferring an application and any supporting documents to the FAA Refugee Offices have been updated for clarity.

Only the FAA Refugee Offices can process a refugee application when the refugee has resided in the United States (U.S.) for less than 12 months. Confirm that the household meets refugee criteria before referring them to the FAA Refugee Offices.

When it is discovered that an application of a refugee is submitted to an FAA office other than a Refugee Office or through HEAplus, complete one of the following within one [workday\(g\)](#):

- Upload the paper application and any supporting documents to OnBase and notify the FAA Refugee Office via an email at faarefugeunit@azdes.gov

In the body of the email, include the participant's first and last name, HEAplus Application ID, or AZTECS case number when the application is in OnBase.

When not already uploaded to HEAplus or OnBase, attach supporting documentation the participant provided with the application to the email.

- Fax the paper application to (623) 931-5676

When faxing the application there is no need to send an email. When faxing documents containing confidential information, use the Fax Cover Sheet (DES-1078A) form.

- When assisting the refugee by phone, data enter the application in HEAplus to preserve the application date. Transfer the application to the appropriate FAA Refugee Office via email.

When the case is already registered, ensure the site code on CARC is one of the following:

- 285 – Applications received in Pima County
- 169 – Applications received in all other counties

Application processing is not restricted to the FAA Refugee Office once a refugee has resided in the U.S. for 12 months.
