General Information: FFY 2024 SNAP COLA

The Food and Nutrition Service (FNS) makes annual changes to standards based on the Federal Poverty Level (FPL). This Cost-of-Living Adjustment (COLA) changes income limits, deductions, and benefits for the 2024 Federal Fiscal Year (FFY) that starts on 10/01/2023.

The monthly rollover for the current system month (CSM) of 10/2023 is 08/26/2023. After 08/26/2023, benefits approved must be authorized in the CSM of 10/2023.

FAA Systems completes a mass change on 09/09/2023. NA cases not in the CSM of 10/2023 are not updated with the mass change. FAA staff must authorize benefits in the CSM of 10/2023 to ensure participants receive the correct benefit amount.

NA cases not in the CSM of 10/2023 must be reworked, including cases authorized in 11/2023 or 12/2023.

The FFY 2024 SNAP COLA changes will be added to the CNAP Manual effective 10/01/2023. A list of the updated policies will be provided in a future What's Changed.
