FAA is currently reviewing and updating notices for clarity. The Division of Child Support Services (DCSS) Requirement (A000) notice is outdated. DCSS pre-compliance for CA is now completed over the phone. Staff only need to provide the participant the appropriate DCSS telephone number and inform them they have 10 days to comply. This information is in the CNAP manual and on the Information Request (A011) notice.
