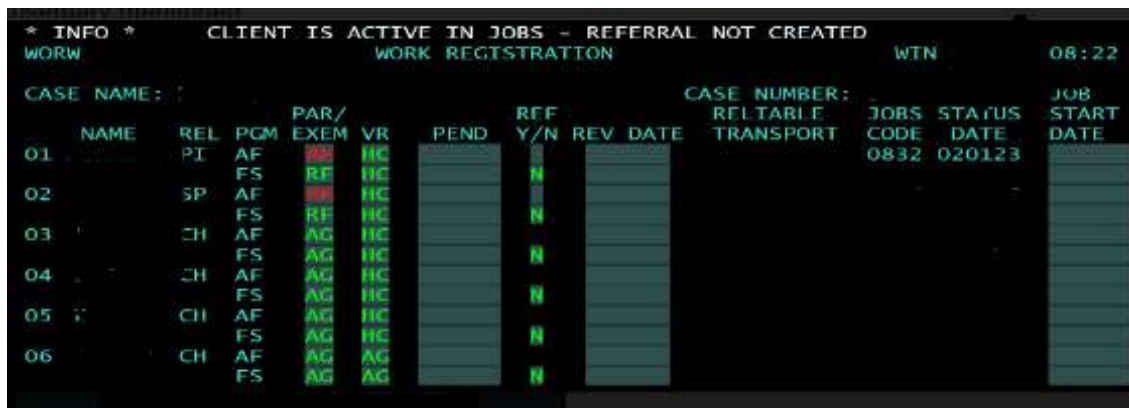

Change: CA Jobs Referrals Issue

EFFECTIVE DATE: For interviews completed on or after 03/20/2023

When CA Mandatory Jobs Referral participants are referred to the Job Opportunity and Basic Skills (Jobs) Program, AZTECS may display the following message:



The message displays when the referred participant is currently active in the Jobs Automated System (JAS).

When this occurs, send an email to DERSHelpDesk@azdes.gov. Complete all of the following when sending the email:

- In the email subject line, add the following: "JAS referral issue - Active in JAS".
- In the body of the email, include the case number and the name of the participant.

The DERS Helpdesk may resolve the issue on the same day it is elevated.

Added information regarding contacting DERS Helpdesk when a CA Jobs referral is not sent due to the participant being active in JAS. (Effective for interviews completed on or after 03/20/2023).

Clarification: Verification of Living Arrangements

The policy for Living Arrangements also known as Household Composition (HHC) has been revised to include which sources are allowed to be used to verify the information.

Only verify living arrangements for NA when questionable. Verify living arrangements for CA, and for NA when questionable, using the following sources:

- Group home records
- Landlord
- Manager
- Neighbors or other nonrelatives
- Other sources, not living in the same home

When the previous listed sources are not available, use the following secondary sources:

- Relatives
- Roommates
- School records

NOTE Do not verify living arrangements for NA participants who are homeless, with no residential address, even when questionable.

Verification can be in the form of a written statement or through a collateral contact. The written statement must include the name of the person providing the statement, the signature, and a contact number.
