EFFECTIVE DATE: Law enforcement requests for participant information on or after 03/27/2023

The DES Governance and Innovation Administration (GIA) clarified that law enforcement must submit a request for participant information to the DES Public Records Request Coordinator.

FAA offices do not release participant information to law enforcement. Refer requests for information from the state or federal law enforcement agencies to the DES Public Records Request Coordinator. The DES Public Records Request Coordinator works with FAA and reviews and completes all requests.

Reformat Update

The CNAP Manual is going through a reformatting project to complete all of the following:

- Change the look and feel by moving the Table of Contents out of an AZTECS roadmap flow.
- Reduce the number of references to make it easier to find what is needed.

At this time, using Search may help with navigation. Anything that has been reformatted will generally show higher in the search results than references in the old format.

The changes made toward the reformatting project effective this week are as follows:

Also, be aware that during this reformat process, reformatted references will change reference numbers, but will stay in the same volume (i.e., FAA1, FAA2, etc.) unless mentioned in this What's Changed section.
