New CA participants must cooperate with the JPPO requirement before CA approval, unless **any** of the following apply:

- The participant meets a CA Jobs Exemption
- JPPO is not required as part of the CA program for any of the following:

Two Parent Employment Program (TPEP)

Grant Diversion

Hopi Family Assistance Program (HFAP)

Salt River Pima-Maricopa Indian Community (SRP-MIC) Life Enhancement and Resource Network (LEARN)

Complete the JPPO compliance with the participant at the interview using **one** of the following:

- Jobs Program Preliminary Orientation (JPPO) (FAA-1808A) Video
- Jobs Program Preliminary Orientation (JPPO) (FAA-1807A) Audio

Jobs Program Preliminary Orientation (JPPO) (FAA-1806A) Script

Clarification: Procedures for Disqualified Participants

Information has been added to clarify how to process cases when there are participants in the budgetary unit that have a drug conviction disqualification. *All* of the following must be considered:

- When there is only one participant in the budgetary unit and the participant fails to respond to a request for verification of a drug conviction disqualification, the case must be closed or denied. Key FE in the DENIAL CLOSURE REASON field on AFED or FSED.
- When there are multiple participants in the budgetary unit, before coding the participant who
 does not meet the NA drug disqualification removal requirements DF, Research and Analysis
 (R&A) approval is required. All remaining qualified participants are coded IN on SEPA to allow
 for an accurate determination of benefits.
- When all participants in the budgetary unit have a disqualifying drug conviction and none of the participants provide the requested verification, key FE in the DENIAL CLOSURE REASON field on AFED or FSED and close or deny the case.

Clarification: CA Benefits in Another State

A participant is not eligible for CA benefits in Arizona (AZ) when they are receiving CA benefits in another state because the participant is not considered an AZ resident for CA.

Before 03/28/2022, a participant was eligible for the difference between AZ CA benefits and the other state's CA benefit amount when the AZ benefits were higher. As of 03/28/2022, this procedure is no longer valid.

When a CA participant is not an AZ resident because they are receiving CA in another state, see <u>FAA3.D07</u> titled Duplicate Participation for CA policy and procedures.

General Information: Navajo Chapter House

The definition of a chapter house is now added to the glossary.

A chapter house is an official meeting place for the Navajo people at a local level. At the chapter house, Navajo people publicly meet to discuss opinions on the business and governance of the Navajo Nation.

The Navajo Nation Department for Self-Reliance (NNDSR) determines CA eligibility for tribal members living in the NNDSR Service Delivery Area (SDA) and non-tribal members living on Navajo tribal lands. The NNDSR office that serves CA applicants is often determined by the nearest chapter house to the residence of the budgetary unit.
