# Change: PIN Signatures via Text Message or Email

EFFECTIVE DATE: The CNAP Manual has been updated as of 03/04/2024

The Personal Identification Number (PIN) signature method has been added as an acceptable signature method.

Applications in HEAplus can be signed using a PIN signature. Assistance from FAA staff is required for signatures to be obtained via text message or email. The PIN signature option requires the PIN to be sent to the participant via email or text message. The participant must provide the PIN to FAA staff within the allotted time frame of ten minutes to complete the signature process.

#### Change: Keying Addresses on ADDR

EFFECTIVE DATE: For all addresses keyed on or after 03/04/2024

Effective 03/04/2024, FAA Systems has made updates to the ADDR screen to expand the address fields and allow for longer addresses to be keyed. ADDR allows 40 characters for the street address field and 20 characters for the city field.
