### **Clarification: Social Security Benefits**

The gross income for Social Security Administration (SSA) benefits is rounded down to the nearest dollar amount when budgeting. This does not apply to Supplemental Security Income (SSI) benefits.

### **Clarification: Signature on the Application for Benefits (FAA-0001A)**

Any official application that meets the criteria for an identifiable application must be accepted and registered, regardless of the date shown on the application.

The required signature on the Application for Benefits (FAA-0001A) revised before 02/2024 is located on a different page than the FAA-0001A revised after 02/2024.

For the signatures on the FAA-0001A revised before 02/2024, **all** of the following apply:

- The signature entered on page one of the FAA-0001A is only for identifiable applications purposes. This signature allows FAA to accept an incomplete application and save the date it is received and signed as the date of application.
- The signature on the last page of the application must be signed under penalty of perjury before a determination can be completed.

For the FAA-0001A revised after 02/2024, the signature is only required on page one of the application.
