### Reminder: Reinstatement Waiver Ending

An [Urgent Bulletin](#) was emailed on 01/27/2026 to inform staff that the reinstatement waiver that allows Arizona to reopen NA cases closed for failure to provide verification during the certification period will be ending.

This change will affect cases closed for failure to provide verification for a reported change or for failure to complete the Mid Approval Contact (MAC).

Effective 02/02/2026, a new application must be submitted when the NA case is closed and **any** of the following occurs:

- The participant provides the required verification for the reported change after the effective date of closure.
- The participant complies with the MAC requirement after the effective date of closure.

NOTE This change does not apply to initial or renewal applications.

Effective 02/02/2026, the NAWA reopening reason code, used to reopen NA cases when the participant complied with all outstanding verification that resulted in the most recent closing of the case within 30 days of the effective date of closure for failure to provide, will be deactivated.
