

H Inquiry Menu (INME)

The Inquiry Menu (INME) lists functions that access inquiry and history screens. Those functions are as follows:

- **PRIOR CONTACT CHECK (CLIN)**
This function accesses CLIN and is used to perform a prior contact check to see when a participant is already known to AZTECS or another system.
- **CASE PROFILE**
This function accesses CAP, which consists of two or more screens of information about the participants in the case.
- **HOUSEHOLD SUMMARY**
This function accesses HOSU, which provides monthly summaries of detailed information for all participants in a case for CA, MA or NA. Not applicable to State Programs.
- **ISSUANCE HISTORY**
This function accesses AFIH, FSIH, and STIH, which display the history of benefits issued for a case during the past 13 months.
- **BENEFIT HISTORY**
This function accesses AFBH, FSBH, MABH, and STBH, which display the history of benefits approved for a case during the past 13 months.
- **NOTICE HISTORY SUMMARY**
This function accesses NOHS, which displays the history of notices sent in the last four months, or those that will be sent.
- **ACTION HISTORY**
This function accesses ACHI, which displays a summary of the most recent actions taken on a case.
- **OVERPAYMENT/CLAIM HISTORY**
This function accesses for VIEW ONLY OVCH, which displays a summary of all outstanding claims and paid claims that have not been purged. This function is not applicable to State Programs.

- **INTERFACE INQUIRY**
This function accesses ININ. Use ININ to view BENDEX, SDX, QCIN and WTPY information for the participant whose Social Security number displays in the SSN field.
 - **AHCCCS TRANSACTIONS HISTORY**
This function accesses AHTR and AHTH, and is used to request and display the participant's history of transactions to AHCCCS.
 - **BUDGET INQUIRY**
This function accesses AFBI, FSBI and MABI, which display the budget history of a case. In some instances, all active months for a case may not have information available.
 - **ABSENT PARENT DATA**
This function accesses APSR, which displays information on an absent parent in a case where the Deprivation Code is CA or DE.
 - **TMA DETERMINATION INQUIRY**
This function accesses TMDA, which displays Transitional Medical Assistance (TMA) information.
 - **HEALTH INSURANCE COVERAGE**
This function accesses HEIC, which is used to access TPL information and HEID for each participant in the case.
 - **CHILDS INQUIRY SCREENS**
(This function is NOT AVAILABLE to FAA staff.)
 - **CHILD SUPPORT PAYMENT HISTORY**
This function accesses CHSP, which displays the following:
 - Up to 18 months of [child support payments](#) issued to a participant through DCSS
 - An alimony or spousal maintenance indicator
- NOTE** Alimony or spousal maintenance PAYMENTS do not display on CHSP.

- **KC/HP REFERRAL HISTORY**
This function accesses KCRE and KCRH, and is used to request and display the participant's AHCCCS referral transaction history.
- **OVERPAYMENT TRACKING**
This function accesses OVTR and is used to key and display referrals for potential overpayment, the status of the referral, and case read information.
- **HOUSEHOLD SYSTEM CHECK**
This function accesses HOSC and displays base wage and unemployment information for each participant in the case. HOSC also displays messages prompting EIs to check the following for each participant, when information is available:
 - ININ
 - CHSP
 - BAGI
