# Change: Temporary Census Income Due to Post-Enumeration Survey

EFFECTIVE DATE: The benefit month of 02/2021 through 10/2021

This change was made to inform staff that temporary census income is not countable during the Post-Enumeration Survey from 02/01/2021 to 10/31/2021.

The Census Bureau is mobilizing temporary census workers to conduct the Post-Enumeration Survey (PES) for the 2020 U.S. Census from 02/01/2021 to 10/31/2021.

Temporary census income is not countable for the Nutrition Assistance and Cash Assistance programs, including Hopi Tribal TANF. Key temporary census income in the INC TYPE field on EAIC in AZTECS using the CE Earned Income Code.

Temporary census income is countable for the Pascua Yaqui Tribal TANF. Key the OA Earned Income Code in the INC TYPE field on EAIC.
