### Change: Voter Registration Policy Updates

EFFECTIVE DATE: With Voter Registration covered transactions on or after 11/22/2021

Changes have been made to the Voter Registration policy for clarification.

The following changes were made to the Voter Registration Policy:

FAA Offices must ensure that the current Arizona Voter Registration (DES-1232A) form is provided. FAA Offices must have a sufficient supply on-hand of the Voter Preference Question (DES-1231A) and Arizona Voter Registration (DES-1232A) forms available for all covered transactions.

For proof of U.S. citizenship, on the Arizona Voter Registration form a customer can write one of the following in the appropriate box:

- Box 9 An Arizona Driver's license number or non-operating identification card number, when issued after October 1, 1996, and the individual was a U.S. Citizen at the time.
- Box 10 Tribal ID Number, Indian Census Number, Bureau of Indian Affairs Card Number, Tribal Treaty Card Number, or Tribal Enrollment Number
- Box 11 Naturalization Number, Alien Registration Number, or Naturalization Certificate Number

For in-person covered transactions, a worker must:

- Offer the customer a Voter Preference Question (DES-1231A) form.
- Ask the customer to complete the DES-1231A form.
- If the customer chooses to register to vote, or does not answer the Voter Preference Question, provide the customer with the Voter Registration (DES-1232A) form.

- Offer to assist the customer with completing the DES-1232A form.
- Assist the customer if they accept assistance.

Instructions were provided for the completion of the Official Use Only section of the Voter Preference Question (DES-1231A) form.

For an individual to be eligible to register to vote, that person must meet the following additional criteria:

- Not have been adjudicated incapacitated with their voting rights revoked.
- When convicted of a felony, have only one felony conviction and complete their sentence, parole, probation, and restitution payment.

#### General Information: Returned Mail

When FAA receives undeliverable mail back from the United States Postal Services (USPS), and there is a forwarding address label on an envelope, AZTECS automatically completes the following:

- Updates the mailing address in AZTECS
- Sends an X006 notice
- Generates an RM ACTS Alert

The actions required to process RM ACTS alerts have been moved to <u>FAA6.A04B.62</u> (internal use only) titled Returned Mail ACTS Alert (RM).
