Change: Converting TPEP to CA

EFFECTIVE DATE: With all eligibility determinations completed on or after 12/12/2022

Additional instruction was added to the procedures for converting TPEP to CA when there is a parent with a disability.

The budgetary unit may no longer be eligible to receive Two Parent Employment Program (TPEP) benefits when any of the following changes occur:

- The two parents no longer have a child in common residing in the home
- There is a parent with a disability anticipated to last 30 days or longer
- One of the parents no longer resides in the home

When a budgetary unit is still eligible for CA and there is a parent with a disability, complete all of the following:

- Remove the U and P indicators from the AA/AF field on SSDO and key a D on the AA/AF field for the appropriate participant.
- Change the UP Deprivation Code on SPRD to the appropriate code for each child.
- Process through all AZTECS screens, including WORW to ensure that a new referral to Jobs is generated for any Jobs mandatory participants.

NOTE Do not change the Participation Code on SEPA for the parent with a disability.

Additional instructions were added when there is a parent with a disability in the budgetary unit and TPEP must be converted to CA. (Effective with all eligibility determinations completed on or after 12/12/2022)

Change: LIBL/STBL Exempt Months

EFFECTIVE DATE: Policy was clarified as of 12/12/2022

CA benefits received from 03/2020 through 05/2022 are not countable towards the budgetary unit's Lifetime Benefits Limit (LIBL) and State Benefit Limit (STBL).

The months that were normally considered countable were waived due to the Declaration of Public Health Emergency caused by the Coronavirus (COVID-19).

When CA is received in any benefit month from 03/2020 through 05/2022, AZTECS displays the @ symbol in the AZ Tracking Display for Cash (AZTD) screen. The @ symbol denotes that the month is not countable towards LIBL/STBL.

Reminder: TPEP Benefit Time Limits

An [Urgent Bulletin](#) was emailed on 12/06/2022 informing staff that the Two-Parent Employment Program (TPEP) Time Limit counter resumed for the benefit month of 07/2022. Unless the participants qualify for an extension, the first benefit month meeting the six-month limit over a 12-month timeframe is 01/2023.

When a TPEP case is approved for a one-time three-month extension, DERS staff informs FAA by sending an email with TPEP Extension Alert in the subject line to FAAchange@azdes.gov. Designated FAA staff receive the TPEP extension approval from DERS by the 20th day of the 5th month. Designated staff then upload all TPEP extension approvals to OnBase using the 'Jobs TPEP Extension Approval' document type.

Designated staff will process the first round of TPEP time limit closures or extensions effective for the benefit month of 01/2023. Designated staff are required to take action beginning in the benefit month of 12/2022 to ensure that the TPEP cases meeting the six-month time limit are closed effective for the benefit month of 01/2023. The CR300 report is programmed to include a separate column that shows the TPEP counter.

NOTE Only designated staff are to work on the TPEP extensions or closures for the benefit month of 01/2023. Beginning with the benefit month of 02/2023, eligibility staff will work the TPEP extensions or closures during the CA renewal process.

The UE Denial Closure Reason Code is active in AZTECS for the benefit month of 01/2023 and ongoing. Negative case determinations for the benefit month of 01/2023 and later can be completed using the UE Denial Closure Reason Code.

When no extension information is received by the required timeframe, staff must take the required actions to approve or deny regular CA and close the TPEP case allowing for NOAA.
