## Change: ACTS Alert Procedures

EFFECTIVE DATE: The CNAP Manual has been updated as of 11/20/2023

Procedures for reassigning and extending Auto Change Tracking System (ACTS) Alerts have been updated and clarified to align with standard work procedures including, and not limited to, **all** of the following:

- An ACTS alert is only to be reassigned to a BES staff member when pending a case read or Quality Control (QC) audit.
- An ACTS alert is only to be reassigned to a local office site code when pending a case read, QC audit, or when the case is in a specialty caseload.
- AZTECS only allows the alert to be extended for ten calendar days and the procedure must be repeated when an alert needs to be extended beyond ten calendar days.
