### **Clarification: Timely Recert Denial and Timely Denial Date**

It is not necessary to wait until the end of the business day to deny the application when the information request tenth-calendar day due date are the same as **one** of the following:

- The Timely Denial date
- The Timely Recert Denial date

When the requested information is provided, reopen the program in AZTECS. (See [FAA6.C02A](#) for Reopening Reasons.)

### **Clarification: CA New Application Timeframes**

Clarification as to what happens within the 45 calendar days with a new CA application. When a denial decision is made timely, the CA application cannot be reopened.

NOTE When a CA application was denied for an incorrect reason, see [Reopening Reasons.A](#) new application needs to be submitted and the process starts over.

### **Reformat Update**

The CNAP Manual is going through a reformatting project to complete **all** of the following:

- Change the look and feel by moving the Table of Contents out of an AZTECS roadmap flow.
- Reduce the number of references to make it easier to find what is needed.

At this time, using Search may help with navigation. Anything that has been reformatted will generally show higher in the search results than references in the old format.

FAA1.A titled Background and Introduction has been reformatted and moved to the following:

- The following moved to a new section under Participant Rights (see [Right to Confidentiality](#)):
  - Address Confidentiality Program (ACP)
  - Handling Special Cases - Address Confidentiality Program (ACP)
- The following moved to a new section under Participant Rights (see [Right to Reasonable Accommodations](#)):
  - Handling Special Cases – Requests for Reasonable Accommodations
  - Handling Accommodation Requests – Visual Impairments
- The following moved to a new section under Agency Responsibilities (see [Avoiding Fraud](#)):
  - Conflict of Interest
  - Handling Special Cases related to Conflict of Interest and Impartiality
  - Suspicious or Potentially Fraudulent Activity
- Handling Special Cases – Customers Under the Influence moved to a new section under Agency Responsibilities. (See [Providing a Safe Environment](#))
- Outside Agencies - Arizona Health Care Cost Containment System (AHCCCS) moved to the appendix in FAA8. (See [Other Places for Assistance](#)).

Temporary links to the reformatted references were added to FAA1.A to help staff who use the table of contents for navigation. These links will be removed after four weeks. Also, be aware that during this reformat process, reformatted references will change reference numbers, but will stay in the same volume (i.e., FAA1, FAA2, etc.) unless mentioned in this What's Changed section.

NOTE It is recommended to use the Internet favorites only for references in the new format because links to the references in the old format will move while under construction.
