Clarification: Additional Case Numbers Created by HEAplus

When an application submitted in HEAplus has not been registered in AZTECS by the Technical Information Process System (TIPS) transfer process, *all* of the following must be completed:

- Review AZTECS to determine whether an additional case number has been created.
- When an additional case number is located, the additional case number must be deleted on DECA in AZTECS by a member of management.

Clarification: NA Expedited Services (NAX) AMPS Calendar Date

To be timely, NA expedited (NAX) benefits must be placed on the EBT card no later than the seventh calendar day from the application date.

The NA/CA Expedited Interview (X905) notice displays the seventh calendar day. The notice provides the participant seven calendar days to complete the interview process for expedited services.

The NA 7 DAY EXPEDITE column on the AZTECS Monthly Production Schedule (AMPS) Timeliness calendar displays the sixth calendar day. This is done to encourage timely NAX determinations and to avoid same day NAX benefit issuances which require EBT Emergency Benefit procedures.

NOTE NAX benefits approved on the seventh calendar day without issuing emergency benefits are available to the participant by 5:00 a.m. on the eighth day and are considered untimely.
